Motion by Golla-Kolosso/ Phelan to approve Consent Agenda. Motion carried.

Approval of Library Bills/ Distribution of Monthly Budget Report- Motion by Brown/ Phelan to approve donation bills of \$ 2,197.87 and general bills of \$1,746.14. Motion carried. Discussion on Budget Report. Director Connor informed Board office supplies budget will run over.

Dennis reported meeting with Martell Construction about the railing rusting and chip paint. Martell deny any more action to be done by them. They offer \$1100 credit off their contract with SML along with a prior \$3000 refund agreed on the front entrance work. Total refund would be \$4,100.

- 5. Meeting with Improvements and Service Committee Update- Connor would like an open dialogue with the committee about maintenance of the Library. Brown will contact the chairperson of the committee and see about scheduling a meeting through City Clerk Cheryl Hass.
